

## Open Access: Frequently Asked Questions (FAQs)

### What is Open Access?

Open Access is a publishing model in which publications are made freely accessible online. Anyone with an interest and an internet connection can access, download, read, copy, print and distribute open access publications with little or no restriction. Open Access increases the visibility and accessibility of research output without delay.

### Is JMSJ an Open Access journal?

JMSJ is currently free to access, with authors paying a publication fee and the Meteorological Society of Japan (MSJ) obtaining the copyright of articles.

From 1 January 2018, all articles published in JMSJ will be published as fully Open Access. All JMSJ articles will still be freely available online, but articles published after 1 January 2018 will be published under a Creative Commons Attribution 4.0 International (CC BY 4.0) license and authors will retain copyright. This license grants allows users to adapt, reproduce and distribute JMSJ articles (even commercially) in any medium provided they give appropriate credit to the author(s) and original source, include a link to the license, and indicate if any changes have been made, without the need to ask prior permission from the MSJ. Authors will be required to sign a License to Publish to grant the MSJ permission to reproduce the work in the journal under the CC BY 4.0 license.

### Do I pay to publish in JMSJ?

Publishing scholarly journals comes with many costs, such as those of managing peer review, copy editing, typesetting and online hosting. To cover these costs in the absence of other income sources such as subscriptions, authors (or their institutions) are requested to pay an article processing charge (APC), as described in the Guide for Authors (<http://jmsj.metsoc.jp/GuideforAuthors.pdf>). There is no submission fee.

### Do members of the Meteorological Society of Japan receive a discount?

Yes. Members of the MSJ receive a discount to the APC for each article type. Please see the Guide for Authors for more information.

### How and when do I pay the article processing charges?

If your manuscript is accepted, the Editorial Office will send the corresponding author a copy of the Open Access payment form with instructions on how to pay the APC. Your manuscript will not be published until this payment has been received.

### How can I get funding to pay the APC?

Some funding bodies allow grant recipients to use part of their grant money towards open access publication. Some universities and research institutions also offer financial support to their researchers to pay APCs. Please check with your funding body and/or employer to see if they have systems in place to pay for, or subsidize, APCs.

Please note that the JMSJ Editorial Office will communicate only with the corresponding author. It is the author's responsibility to coordinate payment with the Editorial Office.

### **Is there a waiver policy for authors from developing countries?**

The journal will waive the APC on an article if no authors have a professional affiliation with a research organization or if all authors are based in a "Least Developed Country" or "Other Low Income Country" on the OECD's qualifying country list. Other waivers will be considered on a case-by-case basis by the journal's Editorial Office. If you would like to apply for a discretionary waiver, you must do so when you first submit your manuscript. Applications made during or after peer review will not be considered.

### **Will Open Access influence the peer review process?**

No. The journal's peer review process remains rigorous and impartial. The Editor's final decision is based only on a manuscript's scientific merit and is not influenced by the authors' ability to pay the APC.

### **Who owns the copyright in my work?**

From 1 January 2018, all authors publishing in JMSJ will retain copyright over their manuscripts. Authors will grant the MSJ a license to publish their manuscript in the journal.

### **What Creative Commons license does JMSJ offer?**

From 1 January 2018, JMSJ will publish articles under the Creative Commons Attribution 4.0 International (CC BY 4.0) license.

### **What rights do I have with respect to my publications?**

As the copyright holders, you and your co-authors retain all the rights normally associated with copyright, subject to the provisions of the License to Publish form and the Creative Commons license.

### **What rights do others have with respect to my publications?**

Under the CC BY 4.0 license, others may use, reproduce and distribute your article (even commercially) in any medium provided they give appropriate credit to the author(s) and original source, include a link to the license, and indicate if any changes have been made. Full details are available at the Creative Commons website (<https://creativecommons.org/licenses/by/4.0/legalcode>).

Creative Commons licenses are valid worldwide and remain in place for as long as the applicable copyrights.

### **Does publishing Open Access mean my manuscript is compliant with my funding body requirements?**

JMSJ's Open Access policies are compliant with the public access requirements of many major funding bodies worldwide. However, you will need to ensure that you and your publications comply with the requirements of your funding bodies or employers.
